Filing Deadline:

Declarations and Petitions of Candidacy must be submitted to the Clerk or Secretary of the District no later than 5 pm on the 9th Friday before the Election (March 17, 2017).

Declarations of Intent for Write-In candidates must be submitted to the Clerk or Secretary of the District no later than 5 pm on the 45th day before the Election (April 1, 2017).

Withdrawal Deadline:

Candidates may submit a Notarized Statement of Withdrawal to the Clerk or Secretary of the District no later than 5 pm on the 45th day before the Election (April 1, 2017).

Filing Deadline:

Declarations and Petitions of Candidacy must be submitted to the Clerk or Secretary of the District no later than 5 pm on the 9th Friday before the Election (September 8, 2017).

Declarations of Intent for Write-In candidates must be submitted to the Clerk or Secretary of the District no later than 5 pm on the 45th day before the Election (September 23, 2017).

Withdrawal Deadline:

Candidates may submit a Notarized Statement of Withdrawal to the Clerk or Secretary of the District no later than 5 pm on the 45th day before the Election (September 23, 2017).

Required Forms for Filing for May or November Elections:

Declaration of Candidacy - Form EC-1A

- 1. Print name exactly as you wish it to appear on the ballot.
 - a. Enter the District Name, Office Title, Term of Office, Election and Date of Election, and Candidate Residence Address.
- 2. Signature of Candidate must be notarized.

Petition of Candidacy - Form EC-1B

- 1. Print name of Candidate.
 - a. Enter the Office Title, Filing Deadline, District or Zone Name or Designation, Candidate Name and Office Title, and Date of Election.
- 2. Circulator must collect signatures of at least 5 eligible voters within the Candidate's Zone or District.
- 3. Signature of Circulator must be notarized.

- 1. Verify that the Petition of Candidacy is signed by not less than 5 electors.
- 2. If the Petition of Candidacy was not verified by the County Clerk prior to submission to your office, contact the County Clerk's Election Office to verify that the 5 electors are properly registered electors.
 - a. If the electors are required to be residents of the candidate's zone, verify that the electors are in the correct zone.
- 3. Stamp or write the date and time of receipt on the front of this document.
- 4. Complete the statement below and transmit a copy of this Declaration of Candidacy to the County Clerk for ballot preparation.
