5. The Superintendent shall be entitled to twelve (12) days of annual vacation, exclusive of school holidays. If this contract expires or terminates prior to the vacation being taken, the Superintendent shall receive compensation, at the rate of her present salary, for the accrued vacation time (not to exceed 50 days), which has not been used.
6. Should the Superintendent be unable to perform all of her duties by reason of illness, accident, or other cause beyond her accumulated sick leave, the District may modify or terminate this agreement with thirty (30) day written notice.
7. The Superintendent may not take a position, sign a petition or endorse any political party while this contract is in effect.
